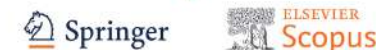

Overview of the Arab Council for Sustainable Development

The Arab Council for Sustainable Development is among the specialized councils operating under the Association of Arab Universities and hosted by Amman Arab University. Its establishment embodies the mission of the Association of Arab Universities to support and coordinate the efforts of Arab universities in preparing individuals capable of serving the Arab nation, preserving its cultural and civilizational unity, and developing its human resources to achieve its aspirations. The Council further encourages the creation of joint Arab research and scientific centers, promotes the exchange of their findings, and prioritizes applied research linked to Arab economic and social development plans.

The Council aims to activate the developmental role of Arab higher education institutions and contribute to entrenching the concept of sustainable development. It fosters a culture of ethical commitment to societal, environmental, and human responsibilities, nurturing a generation conscious of its dual social and humanitarian duties.

Conference Overview

The Third International Scientific Conference of the Arab Council for Sustainable Development, entitled "The Impact of Wars and Conflicts on Sustainable Development," extends the Council's established series of conferences engaging local, regional, and international specialists, academics, and experts. Over two days, the conference will deliberate research papers and distilled lessons from Arab sustainable development experiences across four specialized thematic areas within relevant knowledge fields. Designed as a recurring scientific platform, it enables researchers and experts to present ideas, research outputs, and practical experiences across local, regional, and international scopes to maximize impact and achieve strategic goals. The conference will diagnose critical challenges facing Arab nations and the world in sustainable development, examine universities' roles in addressing these challenges, propose actionable solutions, and construct a forward-looking vision for sustainable development in Arab states. This focus is critically urgent in our conflict-laden world, where wars profoundly disrupt all dimensions of sustainable development – especially in the Arab region. Consequently, educational institutions throughout the Arab world and beyond must prioritize sustainable development's economic, social, and environmental dimensions by integrating them into their core research agendas.

Conference Objectives

- The conference aims to achieve the following key objectives:
1. Highlight universities' contributions to sustainable development during and after wars and conflicts.
 2. Provide a forum for proposing actionable strategies to enhance

universities' role in achieving sustainable development goals in war-affected Arab countries.

3. Facilitate knowledge exchange, research partnerships, and strengthened cooperation among researchers working on sustainable development in conflict and post-conflict contexts.
4. Share expert visions on emerging approaches to sustainable development in post-conflict scenarios across Arab nations and globally.
5. Enrich academic research on sustainable development to serve countries recovering from wars and conflicts.

Conference Themes

1. Environmental Sustainability Axis

- Natural Resource Stewardship: Water conservation, renewable energy, and soil/forest protection during and post-conflicts.
- Climate Change: Climate adaptation, carbon emission mitigation, and conflict-driven climate policies.
- Biodiversity Conservation: Wildlife protection and marine/terrestrial biodiversity preservation in conflict and post-conflict settings.
- Waste Management & Recycling: Advanced recycling strategies and conflict-related pollution reduction.
- International Environmental Accountability: Global responsibility for environmental protection during and after armed conflicts.

2. Economic Sustainability Axis

- Post-Conflict Sustainable Economic Development: Stimulating sustainable growth, reducing unemployment, supporting green industries, and building resilient food security systems.
- Sustainable Finance in Conflict Zones: Innovations in green finance, sustainable banking, and green bonds.
- Circular Economy During & Post-Conflict: Resource reuse optimization and circular economy advancement.
- Technology & Innovation in Conflict Contexts: Technology's role in sustainability and Fourth Industrial Revolution applications.
- Legal Frameworks for Reconstruction Investment: Mobilizing post-conflict rebuilding investments through legislative measures.
- Labor Market Impacts of Conflict-Induced Displacement: Effects of war-driven forced migration on employment structures.
- Divine Scriptures' Role in Economic Justice: Promoting fair economic values through religious teachings during and after conflicts.

3. Social Sustainability Axis

- Education & Human Development in Conflict Settings: Capacity building, sustainable education support, and community awareness initiatives.
- Public Health & Psychosocial Welfare: Developing resilient public health systems and enhancing quality of life during conflicts.

- Social Justice & Equality: Gender equality advancement, human rights protection, and poverty eradication frameworks in war zones.
- Community Cooperation: Strengthening social cohesion during and after conflicts through collective action.
- Legal Frameworks for Post-Conflict Recovery: Legislative measures addressing war aftermath and societal rehabilitation.
- Divine Scriptures' Social Role: Promoting social cohesion and peacebuilding through religious teachings in conflict contexts.

- **Successful Case Studies:** Showcasing effective sustainable development models implemented in conflict-affected Arab nations.
